Our Cause

Crimes against children are among some of the most heinous and disturbing that law enforcement encounters.

The Union County Prosecutor's Office established the Child Advocacy Center of Union County in 1995 to respond directly to such crimes. The state-of-the-art service facility where the Center is now located opened in 2012 and is celebrating its 10th Anniversary. Today the Child Advocacy Center tends to the needs of the more than 1,100 people who visit it annually in order to utilize its resources.

At the Center, young victims of physical and sexual abuse can disclose the details of the crimes against them in a calming environment. Its "wrap-around" service model features investigative, prosecutorial, psychological, medical, and mental health services all provided under one roof, with referrals also made for follow-up treatment.

Disclosure of child sexual abuse has a devastating impact on a family's life and economic security. The Friends of the Child Advocacy Center of Union County, Inc., a 501(c)(3) non-profit (the "Friends"), is raising funds to provide emergent services and supplies, not available from other sources, to child abuse survivors and their families in Union County. Additionally, donations have supported a Summer 2024 public awareness campaign to prevent child drowning in New Jersey. In the past, the Friends have paid costs related to mental health intake screening and continued trauma-focused counseling for abuse survivors. Given the past instability of State and Federal counseling grants, the Friends stand ready to continue to support these costs as needed.
